# Learn - Dig deeper into the issues

#### **Addressing Pay Equity in the States**

The Department of Labor Women's Bureau issued a **new analysis** on the gender and racial wage gap, including data by occupation, age, and educational attainment, along with information on states' policies related to equal pay and pay transparency protections. It's important to examine data on a local level, as each state has its own gender pay gap and unique needs that shape lasting policy changes. In this year of state advocacy, AAUW will provide the tools you need to be a champion for pay equity.

To date, there are 16 states, plus Puerto Rico, with salary history bans, and eight states with laws requiring salary range transparency in job announcements. AAUW has long fought against the use of salary histories; relying on salary history to set future salary assumes that prior salaries were fairly established in the first place. Ending this practice will go a long way in our fight for pay equity. In March, the Biden-Harris administration convened state legislators who are working to advance bills that would prohibit the use of salary history by employers in setting pay, along with other pay transparency legislation.

The Women's Bureau released a new analysis and issue brief highlighting salary history bans as an effective tool to reduce gender and racial wage gaps in the United States.

**Pennsylvania's primary** election system is a closed shop: Only registered Democrats or Republicans can vote in races that affect the lives of every Pennsylvanian. In April State Senators Dan Laughlin, R-Erie, and Lisa Boscola, D-Northampton, formally introduced legislation that would allow unaffiliated voters to participate in tax-payer-funded elections. The measure is now before the Senate's State Government Committee. Pennsylvania is one of only nine states that bar independent voters from participating in primary elections.

### ERA proposal reaches 100 year mark

his year marks the 100th anniversary of the introduction of the Equal Rights Amendment (ERA), which would provide a constitutional guarantee that all men and women are truly equal under the law. The ERA has now met all the requirements for ratification by Congress.

AAUW national now calls for the 28th Amendment to be formally published as part the Constitution and asks members to contact legislators to affirm the ERA as the 28th Amendment. Having the ERA in effect could help move pay equity legislation through Congress, provide additional support for new and existing protections to address sexbased discrimination in schools and in the workplace, and access to reproductive health care. This year, ERA has gained new momentum.

In March, the first-ever Congressional Caucus for the Equal Rights Amendment was launched. In May, we saw the Senate take the first vote on ERA in decades. And most recently, we saw the introduction of the ERA Now resolution, which directs the Archivist of the United States to affirm the ERA as the 28th Amendment of the United

States Constitution, certify the state ratifications, and publish it in the Federal Register. It is the first time ever that ERA legislation will be led by women in both the House and the Senate together!

Tell Congress to make this the year of victory: affirm the ERA as the 28th Amendment!
